Permission has been granted by the Barn Hunt Association, Inc. for the holding of this Barn Hunt Fun Test under BHA Rules and Regulations.

OPEN TO ALL BREEDS AND MIXED BREEDS of all sizes. Dogs **DO NOT** have to register with Barn Hunt Association to participate. The 10 x 20 Blind will be limited to four dogs. Training is permitted with the use of toys or treats.

Trial will be held Outdoors, Covered/Open Sided, Grass, and Dirt.

Classes offered: Instinct, Novice, Open, Senior and Master

Fun Test ONLY; No titles can be earned. No Placements ribbons will be supplied. **Special Awards will be presented per level.** Dogs marked as training are ineligible for awards.

Trial grounds are on public business property and include multiple parking lots and grassy areas for canine relief. Please be aware there are free roaming cats on this property. The site is handicap/wheelchair accessible.

Judge - Terry Russo

Trial opens on October 25, 2020. Entries will be accepted in the order received until December 3, 2020 at 8:00 p.m. with the Trial Secretary. Judge is limited to 8 hours of judging and a maximum run value, which will require this club to limit entries accordingly.

Day of Show entries are accepted pending space availability.

BHA INTERIM COVID RULES WILL BE STRICTLY ENFORCED.

Directions to the Event

From Florida's Turnpike North or South:
Take exit 133 toward FL-714/Stuart
At traffic light, Turn left onto FL-714 W
In 0.4 mi Turn left onto SW Leighton Farm Ave
In 0.5 mi, 4100 SW Leighton Farm Ave, Palm City, FL 34990 will be on your Right.

From I-95 Southbound:

Take exit 110 to merge onto FL-714 E (Turn Left at end of ramp)
In 5.2 miles, turn Right onto SW Leighton Farm Ave
In 0.5 miles: 4100 SW Leighton Farm Ave, Palm City, FL 34990 will be on your Right.

From I-95 Northbound:
Take exit 102 toward Palm City
Merge onto SW High Meadow Ave
In 2.7 miles turn Left onto SW Martin Hwy
In 0.7 miles turn Left onto SW Leighton Farm Ave
In 0.5 miles: 4100 SW Leighton Farm Ave, Palm City, FL 34990 will be on your Right.

From West/FL-70:

From FL-70 Take Slight right onto FL-710.
In 9.9 miles turn Left onto SW Martin Hwy

Ring 1 - Instinct, Novice, Open, Senior, Master. Running Order - Dogs will be run in height order (small to tall) with dogs being handled by the same person separated into different staged groups.

All classes will be run in blinds of four dogs.

Treasured Canine Academy (the Club) reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Club or any official thereof. Dogs may not be brought to the gate in any disallowed collar or on a Flexi-lead. Dogs MUST run "naked," without a collar/harness. Dogs should be brought to the ring with collars/harnesses which can be easily and quickly removed and replaced.

Bitches in Season: may enter this trial but are required to be kept separate from all other dogs and will be run at the end of their class/trial. They must wear pants/britches at all times including on the course. Entry fees for bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. If bringing a bitch in season, please inform the trial committee prior to the trial. Judges are not required to wait for dogs. The owner or handler of each is solely responsible for having the dog ready when his/her class is to be judged.

It is expressly understood that participants are responsible for the behavior of their dog(s). Participants whose dogs create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the event committee, be asked to leave the event site. In such case, no refund of any fees paid will be made. The Club will assume no responsibilities for any loss damage or injury sustained by participants or spectators, or to any of their dogs or property

It is your responsibility to read and be familiar with BHA rules, with includes but not limited to facility grounds, collars and leashes allowed, and current temporary COVID-19 rules. They can be found at www.barnhunt.com

The running order and further scheduling details will be e-mailed to all exhibitors no later than Tuesday, December 8, 2020, after the actual number of entries is known for each class. If you do not receive an e-mail by Tuesday evening, please contact the trial secretary. Dogs will be run small to large; dogs being handled by the same person will be separated into different staged groups. Dogs may be measured at the discretion of the judge.

Run order based on Small to Large Height Divisions:

Small: Dogs 13" & under Medium: Dogs 13.1" to 18" Large: Dogs over 18"

Refunds:

Entry fees WILL be refunded:

- If the entry is withdrawn prior to the closing date (December 3, 2020).
- If the competitor who entered the fun test must withdraw due to suspected or confirmed COVID-19 or direct exposure to a COVID-19 patient.
- If the event must be cancelled by BHA, State, or local authorities.

Entry fees will NOT be refunded:

- In the event that a dog is absent, disqualified, excused, or barred from competition by the action of the Event Committee.
- If the trials cannot open or be completed by reason of riots, civil disturbances, fire, and act of God, public emergency, act of a public enemy, or any other causes beyond the control of the Event Committee.

NOTICE TO EXHIBITORS

- Please expect to crate out of your vehicle.
- Bring your own water and bowls for your dogs.
- Possessing or training with personal, live quarry is not permitted on the trial grounds at any time.
- Dogs must be on a leash at all times except when in the ring.
- Leashes cannot be left dangling or dragging.
- Exhibitors are responsible to clean up after their dogs. Relief areas designated by the club will be clearly marked.
- Exhibitors are responsible for being ready to go to the Blind and waiting for the call to the gate when it is their turn to run. The judge need not wait for any dog holding up a class.
- The Club assumes no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, spectators, or to any of their dogs, property, or children.

SPECIAL NOTICE FOR COVID-19

- General spectators are not allowed.
- All event attendees must provide their own masks/face shields in a sufficient number to make it through the event.
- Competitors must wear masks in the blind, coming to the ring, in the ring, and any time they will be within 10' of another person on Trial Grounds who is not part of their personal household.
- Guidelines are subject to change, as needed for the safety of all fun test participants.
